Now, therefore, the parties agree as follows:

1. Vendor shall have access to the location agreed upon by the parties no less than **2** hours before the Event's commencement at **10 AM** for the purpose of setting up Vendor's vending station, goods, and other things necessary and reasonable to vending at the location.
2. Vendor shall not vend any goods or services other than those described herein at and during the Event without the SIS's written consent.

3. Vendor's vending station shall be no larger than **10 x 10** feet or taller than 8 feet (if a tent). Site shall be clean and orderly; and shall comply with all applicable laws and regulations.

5. All permits required by the Suffolk County Department of Health are applied for and submitted by June 15, 2015; both Food Source Documentation and a Permit for Temporary Events are required and need to be posted at your location to serve food at the fair.

4. Vendor's staff may announce the availability of the goods to be vended only while they are within the confines of the vendor's location.

5. Vendor's staff shall be clothed and groomed in a clean, neat fashion and shall conduct themselves in an orderly fashion.

6. No loud music, noise, or sound amplification devices shall be used by vendor's staff at the location.

7. Vendor shall have access to the location for up to **3** hours after the Event's conclusion at **6:00 PM** to dismantle and remove all things brought to the location by Vendor. Vendor shall leave the location clean of trash and substantially in the condition it was before Vendor occupied it.

8. Vendor hereby agrees to indemnify and hold harmless the Host against any damages or claims that may arise in connection with Vendor's presence at the Event and Vendor's activities of any kind.

I understand that I am solely responsible and liable for my property at all times while at the Fisherman's Fair and that the Springs Improvement Society, its board of directors and the Fair Coordinator will not be liable in the event of any damage, theft or injury. In the event of bad weather, the fair will be rescheduled to the next day. In the event of cancellation your vendor fees will be refunded.
